Cancellations received on or before Monday, January 24, 2022, will be refunded 50% of all registration fees. Cancellations or registrations received after the cancellation deadline of Monday, January 24, 2022, will not be eligible for a refund. Refunds will be issued no later than February 11, 2022.

SUBSTITUTION POLICY Substitutions are only permitted on the day of cancellation.
