## Event Cancellation & Substitution Policy

Cancellations received on or before **JANUARY 19, 2024**, will be refunded 50% of all registration fees. Cancellations or registrations received after the cancellation deadline of **JANUARY 19, 2024**, will not be eligible for a refund. Refunds will be issued no later than **FEBRUARY 23, 2024**.

**SUBSTITUTION POLICY:** Substitutions are only permitted on the day of cancellation.
